Additional affiliation for starting B.Tech Civil Engineering and Production Engineering and MCA programmes with an intake of 60 students each during the academic year 2006-07 was granted vide U.O. read as 2nd and 3rd above. The intake of B.Tech Electronics & Communication Engineering was increased from 60 to 120 during the acadmic year 2010-11 with permission to start classes during 2011-12 vide U.O. read as 4th above.

The intake of students in B.Tech Mechanical Engineering was enhanced to 120 vide U.O. read as 5th above. The intake of B.Tech Civil Engineering and B.Tech Computer Science & Engineering courses were increased from 60 to 120 during the academic year 2013-14 vide U.O. read as 6th above.

The Continuation of Provisional Affiliation was granted to B.Tech, M.Tech and MCA programmes for the academic year 2015-16 vide U.O. read as 7th above.

Affiliation granted is strictly provisional and only for the academic year 2016-17. The college has to apply for continuation of provisional affiliation for the ensuing years by remitting the fee fixed by the University along with a copy of approval order from the apex body concerned.

The conduct of University Examinations of any sort including that of SDE Examinations is compulsory and binding on all colleges affiliated to the University of Calicut.

Selection and admission shall be made only on the basis of the rules and regulations of the University and Government from time to time, failing which the affiliation granted will automatically be cancelled.

The list of colleges which have renewed their provisional affiliation or applied for Continuation of provisional affiliation will be forwarded to the Office of the Controller of Examinations to see that examinations are not conducted in those colleges which have not applied for Continuation of Provisional Affiliation.

In the light of the directions of the Supreme Court of India WP (C)656/1998, the Institution shall take appropriate measures for prevention of ragging any form. In case of failure to prevent such instances, appropriate action including withdrawal of affiliation of the college will be initiated.
