1. INTRODUCTION

2. DURATION OF COURSES

- a) B.Tech degree course will be completed over a period of 4 years consisting of 8 semesters.
- b) B.Tech (LE) students will complete the course over a period of 3 years consisting of 6 semesters.
- c) M.Tech course will be completed over a period of 2 years consisting of 4 semesters.
- d) MCA course will be completed over a period of 2 years consisting of 4 semesters.

3. ACADEMIC ELIGIBLITY

A. Eligibility Criteria for B.Tech Admission in Govt Quota

a) Candidates who have passed Higher Secondary Examination, Kerala, or Examinations recognized as equivalent thereto, with Physics and Mathematics as compulsory subjects and Chemistry as one of the optional subject with at least 45% marks put together in the above subjects are eligible for admission. In case, the candidate has not studied Chemistry, the marks obtained in Computer Science shall be considered. In case, the candidate has not studied Chemistry and



Computer Science the marks obtained in Biotechnology shall be considered. In case, the candidate has not studied Chemistry, Computer Science and Biotechnology the marks obtained in Biology shall be considered. The marks as shown in the mark list of the Board of Examination obtained from the respective Higher Secondary Board shall be considered for academic eligibility.

b) Candidates should have passed and be ranked in the KEAM-2024.

B. Eligibility Criteria for B.Tech Admission in Management Quota

- a) Candidates who have passed Higher Secondary Examination, Kerala, or Examinations recognized as equivalent thereto, with 45% marks in Mathematics, Physics and Chemistry put together.
- b) Qualified and ranked in the KEAM-2024/JEE-2024 or as per the norms issued by the authorities time to time.

C. Eligibility Criteria for B.Tech Admission in NRI Quota

- a) Candidates who have passed Higher Secondary Examination, Kerala, or Examinations recognized as equivalent thereto, with 45% marks in Mathematics, Physics and Chemistry put together.
- b) Qualifying in any entrance exam (KEAM-2024/JEE-2024) is not essential for NRI admission.

D. Eligibility Criteria for B.Tech LE Admission (Govt. & Mgt.)

- a) Diploma in engineering (3 years /2 years (Lateral Entry) course) awarded by the State Board of Technical Education or Equivalent with at least 45% marks (40% in the case of reserved category)
- b) Candidates who have passed B.Sc degree from a recognized university as defined by the UGC with Mathematics at 10+2 level.
- c) Candidates who have passed D.Voc (Vocational Diploma) stream in the same and allied sector in Engineering / Technology awarded by any state board of Technical Education or Institutions under Govt. of India with at least 45% marks (40% in the case of reserved category).
- d) Qualified in the B.Tech LET 2024 entrance exam.



E. Eligibility Criteria for M.Tech Admission

- a) The candidates shall be an Indian National.
- b) The candidate should have B.Tech. Degree in the appropriate branch of APJ Abdul Kalam Technological University or bachelor's degree in Engineering from another University approved by AICTE/UGC approved Deemed Universities in India and recognized to be eligible for higher studies by APJAKTU.
- c) In case of candidates who have started the graduate course in foreign universities, an equivalency certificate from APJ Abdul Kalam Technological University is to be produced.
- d) Candidates, who have passed AMIE/AMIETE Examinations and satisfying the following conditions, are also eligible for admission.

i. They must have valid GATE score.

ii. A minimum of 55% marks for section B in AMIE/AMIETE examination.

- e) The candidate should have a minimum CGPA of 6.0 in a 10 point scale in the Engineering Degree Examination.
- f) Candidates who have appeared for the final semester examination can also apply, provided he /she has passed all the subjects up to and including the 6th semester exam (8th semester for B. Arch students). Confirmation of admission of such candidates shall be subject to the production of qualifying degree before the date stipulated by the affiliated University.
- g) Admission shall normally be restricted to those with valid GATE score. However, this stipulation is relaxed in the case of sponsored candidates. In case seats remain vacant due to lack of candidates with valid GATE score, candidates without valid GATE score shall be considered. Admission to such seats will be made on the basis of their CGPA/% marks scored in their Engineering Degree.
- h) In case the CGPA by any University is mentioned on a scale other than 10 point, then the corresponding CGPA will be proportionally scaled to 10 point scale.



F. Eligibility Criteria for MCA Admission (Govt. & Mgt.)

- a) Candidates should have Passed BCA/ B.Sc.(Computer Science)/ B.Sc. (IT)/B.E.(CSE)/B.Tech.(CSE)/B.E.(IT)/B.Tech.(IT) or equivalent Degree.
- b) Candidates who Passed B.E / B.Tech. / B.Sc. / B.Com. /B.A./ B.Voc. etc with Mathematics at 10+2 Level or at Graduation Level (with additional bridge Courses as per the norms of the concerned University).
- c) Obtained at least 50% marks (45% marks in case of candidates belonging to reserved category) in the qualifying examination.
- d) The candidates seeking admission to MCA course should have a valid score, in the entrance test conducted by LBS. The candidates who have not qualified in the entrance examination cannot be considered for admission to MCA Course.
- e) The eligibility Criteria for MCA Course for the academic year 2024-25 will be based on the norms of the AICTE, Regulation of the University and as per the Prospectus issued by the DTE & approved by the Higher Education Department, Govt. of Kerala.

4. RELAXATION OF ACADEMIC ELIGIBILITY

A. B.TECH -RELAXATION OF MARKS (Govt. Quota Admission)

- a) Following category of candidates are eligible for a relaxation of 5% of marks, provided their total annual income is within Rs.8 Lakhs (subject to Govt. Orders)
- SEBC
- Persons with Disabilities (PWD)
- b) The SC/ST candidates need only pass marks in the qualifying examination

B. M.TECH -RELAXATION OF MARKS (Govt. Quota Admission)

a) For SEBC (OBC) students, the minimum CGPA requirement is 5.5 on a 10 point scale. Wherever the credit system is/was followed, only CGPA will be considered for selection. If the candidate has obtained the bachelor's degree in Engineering from a University where the credit system is/was



not followed, he/she should have a minimum of 60% aggregate marks (For SEBC /OBC students, a minimum of 55% aggregate marks in the Engineering Degree examination is mandatory). For SC/ST candidates a pass in the Engineering Degree Programme is sufficient.

C. MCA -RELAXATION OF MARKS (Govt. Quota Admission)

- a) The aggregate mark required is 45% in SEBC and physically handicapped candidates.
- b) Minimum required pass marks in the degree examination is sufficient in SC/ST candidates.

5. SYLLABUS

The Curriculum for B.Tech, B.Tech LE, M.Tech & MCA courses will be as per the details published by APJ Abdul Kalam Technological University. (https://ktu.edu.in/eu/acd/curriculumSyllabusCommittee.html)

6. HOW TO APPLY FOR ADMISSION TO MANAGEMENT SEATS

ONLINE Application only will be invited through the college website www.vidyaacademy.ac.in as per date stipulated by authorities and by remittance of Rs.500/- towards application & Prospectus fee. Print copy of the ONLINE application form is required to be submitted to the college along with the required documents before the closing date of the application.

The online application form will contain auto generated registration/ application number and auto generate date and time of submission of application. Educational certificates, photograph, signature and relevant certificates to claim the eligibility of the candidate are also to be uploaded. The category shall be clearly specified in the online application form. The category once selected shall not be changed under any circumstances. Printing and photocopy facilities are available in the college.

7. ALLOTMENT OF MANAGEMENT SEATS AND ADMISSION

• B.TECH

a) All applications received up to the notified date will be considered for allotment of seats as per availability of seats.



- b) Candidates will be ranked based on their marks in KEAM 2024 and for PCM in the qualifying exam. Candidates are required to login in to the ERP system to know their rank.
- c) Students and parents are advised to visit college web site regularly. Counseling for seat allotment and admission will be held in the college as per admission schedule notified in the website. Parents/Guardian should accompany the candidates appearing for counseling.
- d) All original documents and complete fees for the semester are to be deposited by the candidates at the time of admission.
- e) All original documents shall be returned after verification and completion of registration in KTU web portal.

• B.TECH LE

- a) Allotment of management seats will be on similar lines followed for B.Tech, unless separate instructions are issued by the Director of Technical education, Govt. of Kerala.
- b) List of documents to be submitted at the time of admission are given in page 13 & 14. Fees structure for courses is given in page 15 & 16.

Note - The procedures are subject to change based on guidelines issued by Govt/Authorities from time to time.

8. HOSTEL FEES



2. DURATION OF COURSES

- a) M.Tech course will be completed over a period of 2 years consisting of 4 semesters.
- b) B.Tech degree course will be completed over a period of 4 years consisting of 8 semesters.
- c) B.Tech (LE) students will complete the course over a period of 3 years consisting of 6 semesters.
- d) MCA course will be completed over a period of 2 years consisting of 4 semesters.

3. ACADEMIC ELIGIBLITY

A. Eligibility Criteria for M.Tech Admission

- a. The candidates shall be an Indian National.
- b. The candidate should have B.Tech. Degree in the appropriate branch of APJ Abdul Kalam Technological University or bachelor's degree in Engineering from another University approved by AICTE/UGC approved Deemed Universities in India and recognized to be eligible for higher studies by APJAKTU.
- c. In case of candidates who have started the graduate course in foreign universities, an equivalency certificate from APJ Abdul Kalam Technological University is to be produced.
- d. Candidates, who have passed AMIE/AMIETE Examinations and satisfying the following conditions, are also eligible for admission.
 - i) They must have valid GATE score.
 - ii) A minimum of 55% marks for section B in AMIE/AMIETE examination.
- e. The candidate should have a minimum CGPA of 6.0 in a 10 point scale in the Engineering Degree Examination.
- f. Candidates who have appeared for the final semester examination can also apply, provided he /she has passed all the subjects up to and including the 6th semester exam (8th semester for B. Arch students). Confirmation of admission of such candidates shall be subject to the production of qualifying degree before the date stipulated by the affiliated University.
- g. Admission shall normally be restricted to those with valid GATE score. However, this stipulation is relaxed in the case of sponsored candidates. In case seats remain vacant due to lack of candidates with valid GATE score, candidates without valid GATE score shall be considered. Admission to such seats will be made on the basis of their CGPA/% marks scored in their Engineering Degree.
- h. In case the CGPA by any University is mentioned on a scale other than 10 point, then the corresponding CGPA will be proportionally scaled to 10 point scale.

B. Eligibility Criteria for B.Tech Admission in Govt Quota

 a) Candidates who have passed Higher Secondary Examination, Kerala, or Examinations recognized as equivalent thereto, with Physics and Mathematics as compulsory subjects and Chemistry as one of the optional subject with at least 45% marks put together in the above subjects are eligible for admission. In case, the candidate has not studied Chemistry, the marks obtained in Computer Science shall be considered. In case, the candidate has not studied Chemistry and Computer Science the marks obtained in Biotechnology shall be considered. In case, the candidate has not studied Chemistry, Computer Science and Biotechnology the marks obtained in Biology shall be considered. The marks as shown in the mark list of the Board of Examination obtained from the respective Higher Secondary Board shall be considered for academic eligibility.

b) Candidates should have passed and be ranked in the KEAM-2024.

C. Eligibility Criteria for B.Tech Admission in Management Quota

- a) Candidates who have passed Higher Secondary Examination, Kerala, or Examinations recognized as equivalent thereto, with 45% marks in Mathematics, Physics and Chemistry put together.
- b) Qualified and ranked in the KEAM-2024/JEE-2024 or as per the norms issued by the authorities time to time.

D. Eligibility Criteria for B.Tech Admission in NRI Quota

- a) Candidates who have passed Higher Secondary Examination, Kerala, or Examinations recognized as equivalent thereto, with 45% marks in Mathematics, Physics and Chemistry put together.
- b) Qualifying in any entrance exam (KEAM-2024/JEE-2024) is not essential for NRI admission.

E. Eligibility Criteria for B.Tech LE Admission (Govt. & Mgt.)

- a) Diploma in engineering (3 years /2 years (Lateral Entry) course) awarded by the State Board of Technical Education or Equivalent with at least 45% marks (40% in the case of reserved category).
- b) Candidates who have passed B.Sc degree from a recognized university as defined by the UGC with Mathematics at 10+2 level.
- c) Candidates who have passed D.Voc (Vocational Diploma) stream in the same and allied sector in Engineering / Technology awarded by any state board of Technical Education or Institutions under Govt. of India with at least 45% marks (40% in the case of reserved category).
 - d) Qualified in the B.Tech LET 2024 entrance exam.

F. Eligibility Criteria for MCA Admission (Govt. & Mgt.)

- a) Candidates should have Passed BCA/ B.Sc.(Computer Science)/ B.Sc.(IT)/B.E.(CSE)/B.Tech.(CSE)/B.E.(IT)/ B.Tech.(IT) or equivalent Degree.
- b) Candidates who Passed B.E / B.Tech. / B.Sc. / B.Com. /B.A./ B.Voc. etc with Mathematics at 10+2 Level or at Graduation Level (with additional bridge Courses as per the norms of the concerned University).
- c) Obtained at least 50% marks (45% marks in case of candidates belonging to reserved category) in the qualifying examination.
- d) The candidates seeking admission to MCA course should have a valid score, in the entrance test conducted by LBS. The candidates who have not qualified in the entrance examination cannot be considered for admission to MCA Course.
- e) The eligibility Criteria for MCA Course for the academic year 2024-25 will be based on the norms of the AICTE, Regulation of the University and as per the Prospectus issued by the DTE & approved by the Higher Education Department, Govt. of Kerala.

4. RELAXATION OF ACADEMIC ELIGIBILITY

A. M.TECH -RELAXATION OF MARKS (Govt. Quota Admission)

a. For SEBC (OBC) students, the minimum CGPA requirement is 5.5 on a 10 point scale. Wherever the credit system is/was followed, only CGPA will be considered for selection. If the candidate has obtained the bachelor's degree in Engineering from a University where the credit system is/was not followed, he/she should have a minimum of 60% aggregate marks (For SEBC /OBC students, a minimum of 55% aggregate marks in the Engineering Degree examination is mandatory). For SC/ST candidates a pass in the Engineering Degree Programme is sufficient.

B. B.TECH -RELAXATION OF MARKS (Govt. Quota Admission)

a. Following category of candidates are eligible for a relaxation of 5% of marks, provided their total annual income is within Rs.8 Lakhs (subject to Govt. Orders)

- SEBC
- Persons with Disabilities (PWD)
- b. The SC/ST candidates need only pass marks in the qualifying examination

C. MCA -RELAXATION OF MARKS (Govt. Quota Admission)

- a. The aggregate mark required is 45% in SEBC and physically handicapped candidates.
- b. Minimum required pass marks in the degree examination is sufficient in SC/ST candidates.

5. SYLLABUS

6. HOW TO APPLY FOR ADMISSION TO MANAGEMENT SEATS

ONLINE Application only will be invited through the college website <u>www.vidyaacademy.ac.in</u> as per date stipulated by authorities and by remittance of Rs.500/- towards application & Prospectus fee. Print copy of the ONLINE application form is required to be submitted to the college along with the required documents before the closing date of the application.

The online application form will contain auto generated registration/ application number and auto generate date and time of submission of application. Educational certificates, photograph, signature and relevant certificates to claim the eligibility of the candidate are also to be uploaded. The category shall be clearly specified in the online application form. The category once selected shall not be changed under any circumstances. Printing and photocopy facilities are available in the college.

7. ALLOTMENT OF MANAGEMENT SEATS AND ADMISSION

• M TECH

- (a) A rank list will be prepared, which will include all the eligible applicants as per clause 3.
- (b) The College will conduct admission from this rank list, after inviting separate application and ascertaining the eligibility for admission as per the norms of the University and following the statutory reservation policy. For filling up of 50%

seats, the college will resort the rank list published by DTE and in the absence of candidates in the rank list by the DTE, other eligible candidates from the rank list prepared by the college will be considered.

- (c) Allotment of management seats will be as per the guide lines issued by authorities time to time.
- (d) All applications received online up to the notified last date will be considered for allotment of seats as per availability of seats.
- (e) Candidates will be ranked based on their mark/rank in their entrance examination and marks scored in the qualifying exam or as per directions received from time to time issued by LBS or the Director of Technical education, Govt. of Kerala whichever is applicable. Candidates are required to login in to the ERP system of the institution to know their rank.
- (f) Students and parents are advised to visit college web site regularly. Counseling for seat allotment and admission will be held in the college as per admission schedule notified in the website. Parents/Guardian should accompany the candidates appearing for counseling
- (g) All original documents and complete fees for the semester are to be deposited by the candidates at the time of admission.
- (h) All original documents shall be returned after verification and completion of registration in KTU web portal.



2. DURATION OF COURSES

- a) MCA course will be completed over a period of 2 years consisting of 4 semesters.
- b) B.Tech degree course will be completed over a period of 4 years consisting of 8 semesters.
- c) B.Tech (LE) students will complete the course over a period of 3 years consisting of 6 semesters.
- d) M.Tech course will be completed over a period of 2 years consisting of 4 semesters.

3. ACADEMIC ELIGIBLITY

A. Eligibility Criteria for MCA Admission (Govt. & Mgt.)

- a) Candidates should have Passed BCA/ B.Sc.(Computer Science)/ B.Sc.(IT)/B.E.(CSE)/B.Tech.(CSE)/B.E.(IT)/ B.Tech.(IT) or equivalent Degree.
- b) Candidates who Passed B.E / B.Tech. / B.Sc. / B.Com. /B.A./ B.Voc. etc with Mathematics at 10+2 Level or at Graduation Level (with additional bridge Courses as per the norms of the concerned University).
- c) Obtained at least 50% marks (45% marks in case of candidates belonging to reserved category) in the qualifying examination.
- d) The candidates seeking admission to MCA course should have a valid score, in the entrance test conducted by LBS. The candidates who have not qualified in the entrance examination cannot be considered for admission to MCA Course.
- e) The eligibility Criteria for MCA Course for the academic year 2024-25 will be based on the norms of the AICTE, Regulation of the University and as per the Prospectus issued by the DTE & approved by the Higher Education Department, Govt. of Kerala.

B. Eligibility Criteria for B.Tech Admission in Govt Quota

- a) Candidates who have passed Higher Secondary Examination, Kerala, or Examinations recognized as equivalent thereto, with Physics and Mathematics as compulsory subjects and Chemistry as one of the optional subject with at least 45% marks put together in the above subjects are eligible for admission. In case, the candidate has not studied Chemistry, the marks obtained in Computer Science shall be considered. In case, the candidate has not studied Chemistry and Computer Science the marks obtained in Biotechnology shall be considered. In case, the candidate has not studied Chemistry, Computer Science and Biotechnology the marks obtained in Biology shall be considered. The marks as shown in the mark list of the Board of Examination obtained from the respective Higher Secondary Board shall be considered for academic eligibility.
- b) Candidates should have passed and be ranked in the KEAM-2024.

C. Eligibility Criteria for B.Tech Admission in Management Quota

- a) Candidates who have passed Higher Secondary Examination, Kerala, or Examinations recognized as equivalent thereto, with 45% marks in Mathematics, Physics and Chemistry put together.
- b) Qualified and ranked in the KEAM-2024/JEE-2024 or as per the norms issued by the authorities time to time.

D. Eligibility Criteria for B.Tech Admission in NRI Quota

- a) Candidates who have passed Higher Secondary Examination, Kerala, or Examinations recognized as equivalent thereto, with 45% marks in Mathematics, Physics and Chemistry put together.
- b) Qualifying in any entrance exam (KEAM-2024/JEE-2024) is not essential for NRI admission.

E. Eligibility Criteria for B.Tech LE Admission (Govt. & Mgt.)

- a) Diploma in engineering (3 years /2 years (Lateral Entry) course) awarded by the State Board of Technical Education or Equivalent with at least 45% marks (40% in the case of reserved category).
- b) Candidates who have passed B.Sc degree from a recognized university as defined by the UGC with Mathematics at 10+2 level.
- c) Candidates who have passed D.Voc (Vocational Diploma) stream in the same and allied sector in Engineering / Technology awarded by any state board of Technical Education or Institutions under Govt. of India with at least 45% marks (40% in the case of reserved category).
- d) Qualified in the B.Tech LET 2024 entrance exam.

F. Eligibility Criteria for M.Tech Admission

- a. The candidates shall be an Indian National.
- b. The candidate should have studied the graduate course in an institution approved by the AICTE / UGC approved deemed universities in India.
- c. In case of candidates who have started the graduate course in foreign universities, an equivalency certificate from APJ Abdul Kalam Technological University is to be produced.
- d. Candidates, who have passed AMIE/AMIETE Examinations and satisfying the following conditions, are eligible for admission.
 - i) They must have valid GATE score.
 - ii) A minimum of 55% marks for section B in AMIE/AMIETE examination.

- e. The candidate should have a minimum CGPA of 6.0 in a 10 point scale in the Engineering Degree Examination.
- f. Candidates who have appeared for the final semester examination can also apply, provided he /she has passed all the subjects up to and including the 6th semester exam (8th semester for B. Arch students). Confirmation of admission of such candidates shall be subject to the production of qualifying degree before the date stipulated by the affiliated University.
- g. Admission shall normally be offered to candidates preferably with valid GATE score. However, this stipulation is relaxed in the case of Sponsored candidates
- h. In case seats remain vacant due to lack of candidates with valid GATE score, candidates from Kerala State without valid GATE score will be considered. If seats are still remaining vacant, candidates from other States will be considered for admission
- i. Candidates should produce conversion formula of their CGPA score if the same is not specifically stated in the mark list or certificate. Otherwise the conversion formula of APJ Abdul Kalam Technological University (2015/2019 scheme) will be taken

4. <u>RELAXATION OF ACADEMIC ELIGIBILITY</u>

A. MCA -RELAXATION OF MARKS (Govt. Quota Admission)

- a. The aggregate mark required is 45% in SEBC and physically handicapped candidates.
- b. Minimum required pass marks in the degree examination is sufficient in SC/ST candidates.

B. B.TECH -RELAXATION OF MARKS (Govt. Quota Admission)

- a. Following category of candidates are eligible for a relaxation of 5% of marks, provided their total annual income is within Rs. 8 Lakhs (subject to Govt. Orders)
 - SEBC
 - Persons with Disabilities (PWD)
- b. The SC/ST candidates need only pass marks in the qualifying examination

C. M.TECH -RELAXATION OF MARKS (Govt. Quota Admission)

a. For SEBC (OBC) students, the minimum CGPA requirement is 5.5 on a 10 point scale. Wherever the credit system is/was followed, only CGPA will be considered for selection. If the candidate has obtained the bachelor's degree in Engineering from a University where the credit system is/was not followed, he/she should have a minimum of 60% aggregate marks (For SEBC /OBC students, a minimum of 55% aggregate marks in the Engineering Degree examination is mandatory). For SC/ST candidates a pass in the Engineering Degree Programme is sufficient.

5. SYLLABUS

The Curriculum for MCA, B.Tech, B.Tech LE and M.Tech courses will be as per the details published by APJ Abdul Kalam Technological University. (https://ktu.edu.in/eu/acd/curriculumSyllabusCommittee.htm)

6. HOW TO APPLY FOR ADMISSION TO MANAGEMENT SEATS

Application will be invited only online through the college website <u>www.vidyaacademy.ac.in</u> as per date stipulated by authorities and by remittance of Rs.500/- towards application & Prospectus fee. No other mode of application is acceptable.

The online application will contain the following particulars:-

- a) Name of the college with address and registration details
- b) Auto generated registration/application number and auto generate date and time of submission of application.
- c) The facility for uploading the photograph, signature and Educational certificates and relevant certificates to claim the eligibility of the candidate should also be provided.
- d) The category / quota of the applicant.
- e) The declaration of the candidate that the details provided in the application are true to the best of knowledge.
- f) The facility for taking printout of the application.

7. ALLOTMENT OF MANAGEMENT SEATS AND ADMISSION

• MCA

- a) All applications received online up to the notified last date will be considered for allotment of seats as per availability of seats.
- b) Candidates will be ranked based on their mark/rank in their entrance examination and marks scored in the qualifying exam or as per directions received from time to time issued by LBS or the Director of Technical Education, Govt. of Kerala whichever is applicable. Candidates are required to login in to the ERP system of the institution to know their rank.
- c) Students and parents are advised to visit college web site regularly. Counseling for seat allotment and admission will be held in the college as per admission schedule notified in the website. Parents/Guardian should accompany the candidates appearing for counseling.
- d) All original documents and complete fees for the semester are to be deposited by the candidates at the time of admission.
- e) All original documents shall be returned after verification and completion of registration in KTU web portal.
- f) Entire admission procedure pertaining to the inviting of applications by online and giving admissions to the eligible candidates observing inter se merit will be completed on or before the last date of closing of admission prescribed by the competent authorities and the fact reported immediately to this committee.
